Lesson plans are monitored by the building principal to determine if the West Virginia College and Career Readiness Standards (WVCCRS) are being used to provide high-quality curriculum and instruction. Big Otter Elementary School works diligently to provide high-quality curriculum and instruction in a supportive and effective learning environment by use of a focused instructional and assessment program, emphasizing individual instruction, time on task, teacher-parent communications, and improved student self-concept and peer relationships.

Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement.

Big Otter Elementary School with the help of parents organized an Open House on August 21, 2023. During this time the following topics were discussed with parents: expectations, WVCCRS, discipline policy, attendance, Title I, etc. Big Otter Elementary School is a school-wide Title I school and informational brochure was given to parents as they entered the building. Big Otter parents had adequate time during the open house to meet their child's teacher(s) and address concerns.

Provide parents reasonable access to staff. Specifically, staff will be available for consultation with parents as follows:

Big Otter Elementary School will provide parents reasonable access to staff by means two formal parent teacher conferences and an annual open house. Also, parents may arrange conferences with school administrator(s) or teachers and we strive to accommodate their time frame. Parents have the option of scheduling a conference with their child's teacher(s) during planning period. If the parent is not available at that time, teacher routinely set up meeting with parents after hours. Also, parents may e-mail teachers if they have a question or concern.

Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows:

Big Otter offers parents many opportunities to volunteer at school. They assist with many of the activities that are offered at Big Otter, such as, Reading to a Class, Open House, Library Duty, Awards Program, 5th Grade Reception, Picture Day, Year Book, Fundraising Activities, etc. They may visit their child's class and observe after making prior arrangements with the building principal. By making prior arrangements, interruptions to the reading blocks are kept at a minimum.

Parent Responsibilities

- Monitoring amount of television their children watch.
- Volunteering in my child's classroom.

Student Responsibilities

- Do my homework every day and ask for help when I need to.
- Read at least 30 minutes every day outside of school time.
- Give to my parents or the adult who is responsible for my welfare all notices and information received by me from my school every day.

School Responsibilities

The Big Otter Elementary School will:
